Sealed bids must be submitted to the office of Armed Police Force, Nepal Headquarters, Procurement Division Halchowk, Kathmandu by hand/courier and electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 noon on 2076/05/05. Bids received after this deadline will be rejected.
 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2076/05/05 at the office of Armed Police Force, Nepal Headquarters, Procurement Division. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format in case of e-bid, amounting to above-mentioned Bid security amount column, which shall be valid for 30 days beyond the validity period of the bid.
 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
 8. The purchaser reserves the rights to accept or reject any bid and to annual the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to the Bidders.
