1. Armed Police Force, Nepal Headquarters (APFN HQ), Procurement Division electronic bids from eligible bidders for the procurement of below mentioned Goods under National competitive bidding Single Stage Two Envelope procedures specified in Public Procurement Act and Regulation.

5. Pre-bid meeting shall be held at Armed Police Force, Nepal Headquarters (APFN HQ), Procurement Division, Halchowk, Kathmandu, Nepal at 13:00 hrs. 19th Aswin, 2080.
6. Electronic bids must be submitted to the office of The Armed Police Force, Nepal Headquarters Procurement Division through PPMO's e-GP system www.bolpatra.gov.np/egpon or before **12:00** hrs. on 30th Aswin, 2080. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00** hrs. on 30th Aswin, 2080, at the office of Armed Police Force, Nepal Headquarters (APFN HQ), Procurement Division. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum below mentioned respective coloum. Which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
