Bidders, submitting their bid electronically, should deposit the cost **NRs. 3000.00** (non refundable) of bidding document in the Project's account number **as specified in table (1)** and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Bids must be submitted to Armed Police Force Nepal Welfare Service Center Halchowk Kathmandu, Nepal through PPMO website www.bolpatra.gov.np/egp on or before **12:00 PM on February 15, 2024.**
6. The bids will be opened in the presence of Bidders' representatives at **13:00 hrs** at Armed Police Force Nepal Welfare Service Center Halchowk Kathmandu, Nepal on **February 15, 2024.** Bids must be valid for a period of 90 days after bid opening date and must be accompanied by a bid security amounting of **NRs 245000.00** which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The bidder must provide any clarification asked by the employer as per sub-clause 4 of clause 23 of Public Procurement Act 2063 (latest revision) and as per **ITB 24** of bid documents during examination, evaluation and comparison by the **[date and Time]**. The bidder who does not provide the clarification of its bid by the **[date and Time]** set by the employer will be rejected.
9. Information not mentioned in this notice shall be in accordance with bid document, Public Procurement Act 2063 (latest revision), Public Procurement Regulation 2064 (latest revision), Electronic Procurement Directives 2074 and other prevailing Law.
