1. Armed Police Force, Nepal No.1 Baraha Brigade Headquarters Sunsari, Nepal electronic bids from eligible bidders for the procurement of below mentioned Goods under National competitive bidding Single Stage Two Envelope procedures specified in Public Procurement Act and Regulation.

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of 11B 23 of the Bidding Document.

5. Pre-bid meeting shall be held at Armed Police Force, Nepal No.1 Baraha Brigde Headquarters Sunsari, Nepal at 13:00 hrs. 29th Magh, 2080.

6. Electronic bids must be submitted to the office of The Armed Police Force, Nepal No.1 Baraha Brigde Headquarters Sunsari through PPMO's e-GP system www.bolpatra.gov.np/egpon or before **12:00** hrs. on 8th Falgun, 2080. Bids received after this deadline will be rejected.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00** hrs. on 8th Falgun, 2080 at the office of Armed Police Force, Nepal No.1 Baraha Brigade Headquarters Sunsari Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum below mentioned respective coloum. Which shall be valid for 30 days beyond the validity period of the bid.

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
