4. Pre-bid meeting shall be held at APFN HQ, Procurement Division, Halchowk, Kathmandu, on 09th September 2021 at 13:00 Hrs (Nepal Standard Time).
5. Bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 noon on 27th September 2021, Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend on 27th September 2021 at 13:00 hrs at the office of APFN HQ, Procurement Division. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format, amounting to above-mentioned column, which shall be valid for 30 days beyond the validity period of the bid.
7. If the Pre-bid meeting/bid opening / submission date falls on a government holiday, then the next working day shall be considered as the scheduled date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
