Invitation for Bids for the following Contracts

1. **Armed Police Force Nepal** invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of Steel Structured Prefabricated for the following Works as specified in table (2) under National Competitive Bidding procedures. The estimated amount for the works is specified in table (2).
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the offices as specified in table (2) or may visit PPMO website www.bolpatra.gov.np/egp.
3. A complete set of Bidding Documents may be purchased from *the respective offices as specified in table (2)* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs.3000.00 as specified in table (2) till office hours. Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents from *respective offices as mentioned in table (2)* or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (NRs. 3000.00) of bidding document in the Project's Rajaswa (revenue) account as specified in table 1 and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at the respective offices as specified in table (2) at 12:00 pm on August 5, 2020.
5. Sealed bids must be submitted to the respective offices as specified in table (2) by hand/courier or electronic bids through PPMO website www.bolpatra.gov.np/egp on or before 12:00 PM at the respective offices as specified in table (2). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 PM at the respective offices as specified in table (2). Bids must be valid for a period of 90 days after bid opening date and must be accompanied by a bid security amounting of NRs.2,93,000.00 which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Only eligible bidders with the following Key Qualification Criteria should participate.

The bidder must provide any clarification asked by the employer as per sub-clause 4 of clause 23 of Public Procurement Act 2063 (with latest revision) and as per ITB 24 of bid documents during examination, evaluation and comparison by the [date and Time]. The bidder who does not provide the clarification of its bid by the [date and Time] set by the employer will be rejected.
10. Matters not covered in this notice shall be in accordance with bid document, Public Procurement Act 2063 (with latest revision), Public Procurement Regulation 2064 (with latest revision), Electronic Procurement Directives 2074 and other prevailing Law.
